

## 1. Competition Venue

## 2. Registration

2.1 Corporate teams who participated in previous Vollé 650 seasons are given top priority in securing their slots for the 5<sup>th</sup> season.

### 2.1.1 On confirming/securing slots:

**To secure a slot, teams need only sign the waivers and fax it NO later than 1 August 2008. No waiver no slot. Cut-off on the 12<sup>th</sup> team.**

2.2 **Registration Period is from 9 July 2008 until 1 August 2008.**

2.3 The registration sheet, info sheet, jersey sheet and waiver are provided. Soft copies of Team Registration Forms and info sheet must be e-mailed on or before **1 August 2008**. Contact details of the tournament director are as follows:

ALL sheets are to be submitted TYPEWRITTEN with complete information and photos. The tournament director reserves the right to NULLIFY players with incomplete information.

## 3. Competition Schedule

Vollé 650 Season 5 - Open Division kicks-off on 6 September 2008.

3.1 The preliminary schedule and game format will be released during the **Captain's Meeting (date, time & venue TBA)** upon which new teams will draw slots to determine their schedule. Based on the schedule presented, teams may formally request changes in their schedule within 3 days of release with consent of affected teams.

3.2 **FINAL** schedule will be posted at [volle.yehey.com](http://volle.yehey.com).

3.3 **On schedule changes.** In the event that a team is in *absolute* need for a change in their schedule after the final schedule is released, approval will be subject to the following:

- 3.3.1 Validity of excuse to be decided solely by the tournament director
- 3.3.2 Approval from **ALL** teams concerned and/or affected by the change in schedule
- 3.3.3 Move to reschedule shall be done 2 weeks prior to **original** scheduled game.
- 3.3.4 Schedule change penalty of Php2,000 to be settled once the change is approved.

Failure to meet ANY of the above conditions shall forfeit the concerned team's move to reschedule their game.

#### 4. Teams and Line-up

- 4.1. Each team is allowed a maximum of **15** players.
- 4.2. **Team numbers are strictly 1-15 ONLY.** Should there be lineup changes mid season, new players can only take on numbers 16-20. This is for statistics purposes.
- 4.3. A team should always have 6 players (at least 2 female) on court to be allowed to play at any one match. Failure to field in 6 players (at least 2 female) will mean forfeiture or default of the match.
- 4.4. A Libero may be designated by the team for a particular match (inform referees who your libero will be before the match begins). This Libero must wear a different colored shirt from that of his/her teammates. A different Libero may be appointed in a different match.
- 4.5. **Final** team line-ups (hard copy, TYPEWRITTEN, complete pictures and information) must be submitted during the Captain's Meeting.
- 4.6. **On line-up changes.** In the event that a team is in *absolute* need for a change in their line-up after the Captain's Meeting, approval will be subject to the following:
  - 4.6.1 Validity of excuse to be decided solely by the tournament director
  - 4.6.2 Eligibility of replacement player – change player announcement will be posted on the website. 1 week grace period for protests upon request of player change to be sent via mail.
  - 4.6.3 New players take on jersey numbers 16-20
  - 4.6.4 Only a maximum of 5 player changes is allowed.
  - 4.6.5 Change lineup penalty of Php2,500 (inclusive of uniform) to be settled once the change is approved. 2 weeks lead time for uniform production.
- 4.7. **There will be 12 teams for this division. Qualification for teams will be on a *first-come first-serve* basis.** Your team representative will be notified if there are no more slots available.

#### 5. Eligibility

All players in the line-up should be current employees of the company being represented.

- 5.1. Exclusions
  - 5.1.1. Current varsity players
  - 5.1.2. College level students - undergrads (born January 1, 1987 onwards)
  - 5.1.3. V-league participants (Season 4 conference 1 May 2007 - present)
  - 5.1.4. Current and former (3 year window) members of the National Team, Philippine Air Force, Philippine Army, and Philippine Navy are refrained from participating. **Former players from December 31, 2005 and back are qualified to join the tournament.**

Any team member who should fall in any of the categories stated above in the duration of the tournament means disqualification of that team member from playing in the tournament effective on the day he/she starts being part of any of the above mentioned.
- 5.2. Vollé 650 aims to promote fair competition among its participants. It is for this reason that team lineups will be cross-checked. Any player in the submitted lineup found to be a member of any of the aforementioned above will be disqualified.
- 5.3. **ELIGIBILITY MEETING.** All team line-ups will be sent to all team captains after the captains meeting. Eligibility meeting to discuss lineups, entertain protests etc, date and venue will be announced. Please secure proper documents for proof when making protests. All team captains will sign each lineup at the end of the meeting signifying approval.

#### 6. Game Default

##### 6.1 Eliminations

- 6.1.1 Teams will be defaulted according to sets. They will therefore have the opportunity to play the second and third sets.
- 6.1.2 Grace period for each set are as follows:

1 <sup>st</sup> set	15 mins	Default on the 16 <sup>th</sup> minute
2 <sup>nd</sup> set	30 mins	Default on the 31 <sup>st</sup> minute
3 <sup>rd</sup> set	45 mins	Default on the 46 <sup>th</sup> minute

##### 6.2 Quarters-Finals

Teams will be allowed a maximum of 20 minutes before a default is declared. On the 21<sup>st</sup> minute, the officials will formally begin the match by asking the opponent team to serve.

6.3 Default penalty of Php3,000 (Php1000/set during eliminations) shall be imposed on the defaulted team to be settled immediately. The team will not be allowed to play their future matches unless settled. To prevent defaults, please be in the premises *at least* one (1) hour before your assigned game to give allowance in case the games finish earlier than expected.

6.4 Official time will be that of Club650's.

## 7. Team Responsibilities

7.1. The organizer will be in touch with team representatives only. Kindly see to it that updates and other concerns regarding the tournament are properly disseminated to team members.

7.2. Referees' decisions are final. **In the spirit of sportsmanship and camaraderie, please observe proper playing decorum.**

7.3. The organizer has the right to sanction/disqualify a player or team who does not conform to tournament rules.

## 8. Team Uniforms

8.1. Samples of jersey sizes will be available during the Captain's Meeting. Jersey sheets must be completely filled up, TYPEWRITTEN except for the jersey size which you will be filling up during the meeting.

8.2. Vollé 650 Open will only provide one (1) jersey for each member of the team. Teams may opt to have another set made and use this in the tournament. **Please ensure jersey numbers and names match that of the lineup submitted. Uniforms that don't match the line-up will not be allowed.** It is the prerogative of the organizer how the designs of the jerseys will be.

8.3. A high-resolution copy of the company logo must be e-mailed to [volle650@yahoo.com](mailto:volle650@yahoo.com) no later than **1 August 2008**.

8.4. **A no uniform, no play policy will STRICTLY be imposed once the uniforms are released.**

## 9. Ranking

9.1 Ranking shall be based on the number of points won as follows:

Won Game	=	2
Lost Game	=	1
Forfeit / Default	=	0

The team with the most number of points ranks highest.

9.2 In case of a tie:

9.2.1 Between two (2) teams - the "winner-over-the-other" rule shall apply.

9.2.2 Among three or more teams - the PAVA "quotient system" shall apply.

9.2.3 For computation purposes, only matches played by teams involved in that particular round will be considered.

9.3 Under no circumstances will an extra match be played to determine rankings.

## 10. Tournament Fee

A Registration fee of Sixteen Thousand Pesos (Php16,000.00) per team is required to cater tournament needs. Fee includes uniforms. This is due no later than the Captain's Meeting. Failure to settle the tournament fee authorizes the tournament director to open the concerned team's slot to other teams. No team will be allowed to play unless the tournament fee is settled.

Volle 650 is now operates independently from Club650.

## 11. Captain's Meeting & Eligibility Meeting

Team captains or any representative from each team **MUST** be present in the captain's meeting. All questions and concerns will be entertained here.

- All protests will be entertained in this meeting.
- Teams with problem in their lineups will be given a week to replace their member.
